

MOTOR VEHICLE RESTRICTIONS WHILE PROVIDING SERVICES ON STATE STREET

- Must enter and exit State Street from nearest intersecting street to their destination.
- Must be actively loading or unloading (No more than 10 minutes without activity).

EXCEPTIONS

- Authorized emergency vehicles
- Authorized government vehicles
- Madison Metro buses
- City or public utility vehicles while engaged in maintenance, repairs or inspections
- Motor trucks parked pursuant to a street occupancy permit

AUTOS

Vehicles are only allowed on State Street when:

- Displaying a valid State Street Auto Permit and doing one of the following for no more than 30 minutes:
 - Actively loading / unloading.
 - Providing maintenance service function to establishment.
- OR -
- Transporting persons with a disability that limits their ability to walk to a location on State Street.

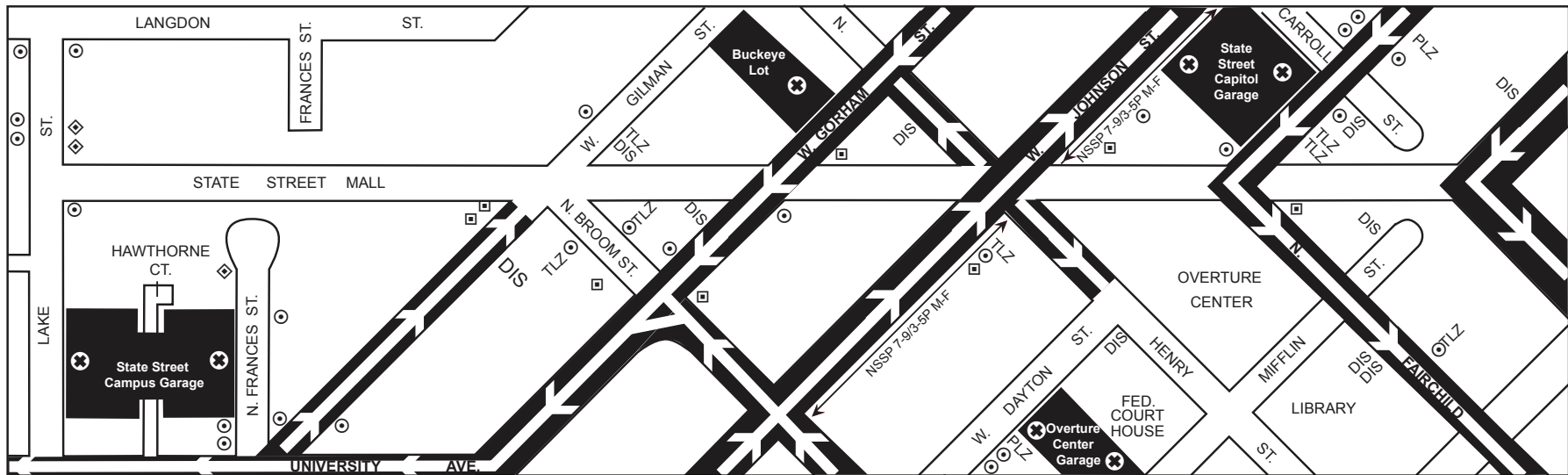
MOTOR TRUCKS

(4 wheeled vehicles with truck plates)

- Must be actively loading / unloading.
- No deliveries between 11:30 am - 1:30 pm daily.

LICENSED TAXI CABS

Only allowed for sole purpose of receiving or discharging passengers specifically requesting service. No staging.

STATE STREET MALL ORDINANCES

063 – No Stopping, Standing or Parking

098 – No Parking bicycles on State Street pedestrian mall

105 – State St. automobile – no stopping, standing or parking

107 – State St. automobile permit violation

122 – State St. automobile parking more than 30 minutes (Actively loading / unloading)

123 – No stopping, standing or parking of motor trucks on State Street from 11:30 am - 1:30 pm

124 – State St. motor truck no stopping, standing or parking for purposes not allowed

127 – No stopping, standing or parking of large motor trucks on State Street from 11:30 am - 1:30 pm

128 – State St. large motor truck parking for purposes not allowed

130 – State St. large motor truck manner of parking (2 trucks across from each other)

132 – State St. large motor truck idling over 15 min when outside temp is between 40°F - 80°F

134 – State St. food delivery vehicle- too many vehicles (before 5 pm = 1 max., 5 pm - 9 pm = 2 max., 9 pm to close = 1 max.)
